
1. Discussion about value of scholarship

  3. Applicant need following documents for OBC scholarship:
    - Caste (OBC) certificate.
    - Matriculation certificate (Photocopy)
    - Passport size photographs.
    - Certificate of domicile of Punjab.
    - Student's Adhaar card.
    - Parent's Adhaar cards.
    - Bank passbook (Photocopy).
    - Gap certificate, if any (Attested by Notary Public).
    - Income from all sources should not be more than Rs. 1,00,000/- per Annum (Attested by Tehsildar).
    - In fatherless case, student can apply through mother's income certificate. In case of death of both mother and father, student can apply through guardian.
- The guardian has to give the affidavit.
