AT ZRO/ARO/UHQ FOR ARTILLERY CENTRE HYDERABAD

1. Reception and Orientation Training at RR & D Battery.

(a) All recruits, on receipt of the call letter, will report to 7 RR & D Battery (7 Recruit Receipt and Despatch Battery) of Artillery Centre Hyderabad by the stipulated date along with all necessary documents that have been specified in the call letter.

(b) Initially all recruits from various BRO/ARO/ZRO are being received at 7 RR & D Battery and kept for a duration of approx 7 days. 7 RR & D Battery, is located on the Hyderabad- Narsighi highway approximately one kilometre away from the main entrance of the Artillery Centre. The recruits will undergo a short capsule of 7 days at 7 RR & D Battery before joining the Training Regiments for their Basic Military Training. During their stay at the 7 RR & D Battery the recruits will undergo training on Orientation to Army way of life through lectures as well as familiarization of the Artillery Centre, Hyderabad.

(c) Mobiles phones WITHOUT camera are ONLY permitted during training with restricted timings. With Camera mobiles will be CONFISCATED. STD booths are also available for communication.

(d) The recruit will be issued with a pair of multi dress consisting of a blazer and other accessories on payment during their training at the centre. They will also be issued with a steel trunk on payment for safe keeping of their personal belongings and valuables. The payment for the above items are approximately Rs 2,600/- will be collected from the recruit during their stay at the 7 RR & D Battery. The monthly pay and allowances of the recruits will commence approximately after 3 months from the date of their arrival at the Centre and the recruit must carry sufficient money at the time of his reporting to meet his basic needs till the commencement of his pay. As a rough guide, all recruits are advised to carry approximately Rs 9000/- with them while reporting to the centre.

Instruction on arrival of candidates at Artillery Centre Hyderabad:-

2. During the period of stay at 7 RR & D Battery the following activities are under taken by the recruits:-

- (a) Reception and accommodation.
- (b) Documentation and Issuing of clothing and equipments
- (c) Commandant's opening address.
- (d) Orientation Training.
- (e) Dispersal to Training Regiments.

3. Recs Training. Basic Military Training and Advanced Military Training of recruited candidates will be carried out with Recruits Leave in between, as per policy in vogue.

4. Aptitude Test. Aptitude Test will be conducted for all Recruits (Sol GD) in the 9th week of their BMT. Individual's trade will be allotted based on their performance.

5. Relegation Policy.

(a) Basic Military Training (BMT).

(i) Failure in Mandatory Tests. During BMT, if any recruits fails in any mandatory Tests (Individual Drill Test, BPET, PPT and Firing) he will be relegated for a max period of 06 weeks and will be discharged from service if he fails to pass during the subject period.

(ii) Medical/Hospitalisation.

(aa) No relegation upto 07 days.

(ab) If the period exceeds more than 180 days, the individual will forego his 30 days of leave upto a maximum period of 210 days. If the hospital admission exceeds 210 days, the individual will be discharged from service.

(iii) Absent without Leave. If any recruits absents himself without leave for a period of 30 days and more he will be dismissed from service.

(b) Advance Military Training (AMT). During the AMT, if any recruits fails in Mandatory Academic Tests, he will be relegated for a maximum period of 13 weeks and beyond which he will be discharged from service.

6. On successful completion of Advance Military Training (AMT) the recruit will be posted out to Artillery Regts after attestation parade.

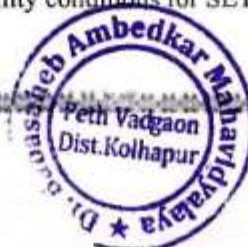




