

- d) "Utilization Certificate" means a duly audited utilization certificate which should be submitted by Coordinator / Organization of Seminar / Congress / Conference / Symposia / Workshop in accordance with the Proforma contained in Annexure XII, which must be on the letter head of the institution and signed by the Convener and Head (With Seal) of Institution (Principal of College or Registrar of University) and Signature (With Seal) of the Finance Officer / Auditor / Accounts Officer (in case of Govt. Office / Department or College or University recognized by UGC / Chartered Accountant (In case of Organization of Seminar / Congress / Conference / Symposia / Conference / Conference / Symposia / Conference / Con
